Sorry if you are getting this late. It's been a wild year end. But all's well that ends well: I did have 5 small strokes but no permanent effects and we're confident (hopeful) its under control - we are watching closely. Shiner is mostly healed and doing well as are all the animals. The demands of TaxAide remain but should slack off in January and hopefully will go better next year. So we are thankful for the good things and hopeful for the coming year. We hope 2013 bodes equally well for you.

Other tidbits of non-news this year: Doing some light PR work for the Habitat Steward program; helping out Austin Wildlife Rescue when they ask; hanging out in the hill country with friends; providing a lap-on-demand for three cats when and where they require it; feeding the deer in the evenings; and hooting at the screech owl who lives in the nest box we put up for her (She always sticks her head out to acknowledge my pitiful "hoot." (I'm not sure if it's out of sympathy, disbelief, or disgust on her part).

The best part of the year was seeing family and friends and reconnecting with others long missed. There were hard parts too. We were saddened by the loss of my mother in April. It was tough saying goodbye, but we were grateful for her release from a long struggle with Alzheimer's. And a dear lifetime friend of mine lost her husband this year to cancer. We will miss him and feel deeply for her loss.
